Under an MoU, the Federation is being managed by the National Dairy Development Board (NDDB).

General Manager

The incumbent should be a result-oriented senior professional with minimum 15 years managerial experience in reputed organisations of which a minimum of three years' experience should be as overall in-charge of a large dairy processing unit or a milk union or a milk producer company.

The candidate should have requisite managerial competence and should be conversant with statutory requirements for operating a milk business. The ideal candidate should have a basic degree in Dairy Technology/ Veterinary Science/ Animal Husbandry/Agriculture/Food Technology/Engineering, with a full time post-graduation degree/diploma in Business Management/Rural Management/Marketing Management from a reputed institution.
