- 1) The tender documents can be downloaded from our website www.jmf.coop from 21.03.2020.
- 2) The Tender shall be duly filled and all pages of the tender should be signed by the Authorized Signatory of Bidder with company seal.
- 3) The bidder should strictly follow the specifications, make/brand for quoting/ offering the price.
- 4) Bid Currencies: -The rate/price should be quoted in Indian Rupees only.
- 5) Any cutting/over writing etc. in the tender must be signed by the person who is signing the tender. The rates shall not be overwritten. The financial figures in commercial bid shall always be both in figures and words. In case of any discrepancy in figures and words, the amount written in words shall be considered.
- 6) The Tenders will be opened on the prescribed date (if mentioned) in the presence of the agency or their authorized representative who may like to be present in the office at Hotwar Dairy Plant of Jharkhand State Cooperative Milk Producers' Federation Limited, Ranchi.

ELIGIBILITY AND DOCUMENTATION CRITERIA:

The bidders must meet the following minimum qualifying criteria:

- 1) The Bidder must be in the business of this type for the last 3 years.
- 2) The bidder must be Manufacturer/Authorized Dealer / for supply of items requested in tender.

The Documents required are:

- 3) A copy of Authorization Letter of the Brand quoted (If bidder is authorized dealer)
- 4) Copy of the Income Tax Returns for three previous years for income tax purpose.
- 5) Copy of GST
- 6) Copy of PAN Card
- 7) A Cancelled Cheque
- 8) Detailed Specification of items with Catalogue (if any)
- 9) Tender document duly signed and stamped by authorized signatory.
- 10) Tender's Profile (as per Annexure I enclosed in Tender)



TERMS AND CONDITIONS: -

- 1) The Tenderer/Bidder must submit its profile duly filled and stamped as per Annexure- I.
- 2) The rate should be quoted in the format enclosed as **Annexure-II** (COMMERCIAL BID).
- 3) The tenderer should provide after sales support (warranty/service) for any maintenance for the period of one (01) year from the date of DELIVERY.
- 4) VALIDITY OF QUOTATION/ OFFER: The quotation must be valid for 90 days from the date of opening of quotations. JMF reserves the right to request the Bidder for the extension of the validity of the quotations. The Bidder will be at liberty to accept or reject the request.
- 5) Participation in this tender is invited from the manufacturer/Authorized Dealer only.
- 6) The bidder shall attach the copy of the authorization letter as the proof of authorization dealer/distributor.
- 7) The offered rate should be on the basis of F.O.R. at destination as mentioned in tender notice. The element of Goods & Service Tax, freight/P&F/Octroi, discount or any should be mentioned clearly stated, failing which it will be presumed that these elements are included in the rates quoted for. Breakup of the price quoted should be given.
- 8) The material is to be supplied strictly as per required specifications.
- 9) In case of any dispute the legal jurisdiction shall be within the jurisdictions of Ranchi only.
- 10) **DELIVERY/ COMPLETION**: Within 30 days from the date of issue of PO.
- 11) The goods will be properly packed before dispatch. All losses in transit due to improper / poor packing will be borne by the supplier.
- 12) The Jharkhand Milk Federation also reserves the option to go in for the purchase of material at the risk and cost of the successful tenderers, if the party fails to give supplies as per our specifications and schedule. The extra amount if any, in doing so will be recoverable from the defaulter.

13) PAYMENT TERMS:

- a. For Supply: 100% within 30 days from the date of receipt of materials/ services and its acceptance.
- b. The payments shall be made through NEFT/RTGS and all payments shall be made in Indian Rupees only.
- **14) Warranty Clause:** Goods manufactured should be free of defects in material and workmanship for 12 months from the date of receipt of delivery and commissioning.
- 15) JMF reserves the right to verify/seek confirmation of all original documentary evidence submitted by Bidder in support of above-mentioned eligibility criterion. In case any information furnished by the bidder is found to be false/incorrect at any stage, the bid shall be summarily rejected and no correspondence on the same shall be entertained.
- 16) Force Majeure: In the event of any unforeseen circumstances directly interfering with the supply of goods/work/service arising during the execution of order such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, earthquakes, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Bidder shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Either party shall have the option to terminate the contract on expiry of 30 days of commencement of such force majeure by giving 14 days "notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other.

- 17) Gode of Ethics: The Purchaser as well as the Bidder shall observe the highest standard of ethics including laws against fraud and corruption in force in India namely "Prevention of Corruption Act 1988", during the procurement or execution of such supply, installation and commissioning orders. If the bidders are found in Bid pooling or against law against fraud and corruption, then their firms may be blacklisted.
- **18)** Submission of tenders shall carry the undertaking that the tenderer concerned has studied the terms and conditions, specifications, quality, type, character and workmanship of the materials tendered.
- 19) Jurisdiction: In case of any dispute, arising out of the contract, the same will be referred to sole arbitration of M.D., Jharkhand State Cooperative Milk Producers' Federation Limited or his authorized representative whose decision in the matter will be final and binding on both the parties. For all legal matters & dispute Ranchi court shall be our jurisdiction.
