The Jharkhand State Milk Producers' Co-operative Federation Ltd (JMF)', Ranchi popularly known as MEDHA DAIRY, registered under Jharkhand State Co-operative Societies Act for our Head Office at Dhurwa and Plant at Hotwar, Ranchi is engaged in milk procurement activities from around 600 Milk Pooling Points through 20000 village milk producers across 15 districts of Jharkhand and marketing of milk and milk products under brand name "Medha", processed through its processing plants at Hotwar, Deoghar, Koderma, Latehar and Lohardaga. JMF also has one Cattle Feed Plant of 50 MT/Day capacity and one Mineral Mixture Plant of 12 MT/Day capacity at Hotwar which produces and supplies high quality Bypass Cattle feed and Mineral mixture respectively. JMF is an apex body of Govt. of Jharkhand State and presently managed by the National Dairy Development Board.

## **Scope of Audit:**

#### A. General:

- 1. Audit of all financial transactions as per delegation of powers and necessity/utility to the Federation and subject to prudent accounting policies and statutory provisions.
- 2. Verification of books of accounts such as cash book, bank book, journal, purchase and sales registers and scrutiny of ledgers.
- 3. Verification of Statutory payments and compliances
- 4. Review of reconciliation of Sales, Vendors, BRS and Stores & Purchase.
- 5. Conduct physical verification of Inventories, Fixed Assets and other Valuables periodically (Monthly/Quarterly) at all operational areas.

Audit of periodical reports and financial/cost statements including operational results

#### **B. Specific Areas:**

- 1. Random Audit of Procurement, Plant & Marketing related activities alongwith verification of Mass Balancing Report of Plant.
- 2. Audit of Capital Expenditure & Fixed Assets Register

- 2. The interested Party/ bidder should submit its Company's Profile in the format enclosed as **Annex-I.** duly signed & stamped.
- **3.** The rate should be quoted in the format enclosed as **Annexure-II.**
- 4. The rate to be quoted in Indian Rupees only.
- 5. Scope of Work as mentioned in the tender document is mandatory to be followed by the Agency/ firm on award of the contract or order.
- 6. The Payment shall be made on monthly basis after completion of the job within 30 days on submission of original bills through NEFT/RTGS.

#### 7. Duration and termination of Appointment

The appointment is with effect from 1<sup>st</sup> April, 2020 to 31<sup>st</sup> March, 2021 and may be renewed on approval by the Management Committee and on such terms and condition as may be agreed upon at the time of such renewal. The appointment can, however, be terminated by giving one month notice in written on either side.

## 8. Fees and Reimbursement of expenses

With reference to the Regulations of ICAI, the tentative fees would be Rs. **60,000.00** (Sixty thousand only) per month plus GST as applicable. The above fee includes out of pocket expenses, conveyance charges etc. Further, for any outstation visit in connection with the audit or physical verification of the units of JMF, necessary arrangements shall be made for the travel, boarding and lodging.
