### TENDER FOR SALE OF BULK GHEE (TERMS AND CONDITIONS)

The Federation is interested to sell 56.00 MT (approx.) old Ghee in 15kg Tin & in Loose packing laying in its store and invites sealed tenders from the interested parties on the following terms and conditions: -

- 1. The interested parties should quote the rate for the full quantity of 56.00 MT (approx.) on as is where is basis. The Federation will however be free to increase / decrease the quantity of ghee at the time of acceptance of offer.
- 2. The tenderer should quote the basic rate Per KG. on ex-Dairy/Factory basis for purchase of ghee. The amount should be indicated both in figures and words. In case of any discrepancy in figures and words, the higher one would be considered. The offer submitted in any other manner will be rejected. All other incidental charges such as GST, Transportation, and Insurance etc. will be extra and borne by the Purchaser/ Tenderer.
- 3. The delivery of Ghee will be made against 100% advance payment including taxes by way of Demand Draft / RTGS and the tenderer must lift the stock within the prescribed given period.
- 4. **Earnest Money Deposit:** The tender must accompany EMD of **Rs.5.00 lacs** (Rupees Five lacs) for 56.00 MT (approx.) of Ghee by way of Demand Draft drawn in favour of "The Jharkhand State Cooperative Milk Producers' Federation Limited, payable at RANCHI. The EMD will be converted in to Security Deposit of the successful tenderer and shall be refunded only after lifting the allotted stock. No interest will be paid on Earnest Money Deposit / Security Deposit. The payment of EMD is compulsory for all the tenderers including Cooperative Federations / Dairies / Institutions etc.
