DETAILED TENDER NOTICE FOR SUPPLY OF RAW MATERIALS & PACKING MATERIALS FOR CATTLE FEED PLANT

Sealed offers are invited from reputed manufactures/suppliers for the supply of Raw Materials for and Packing Materials required for our Cattle Feed Plant, Hotwar, Ranchi. Details of items can be seen in the enclosed format.

Offers may be submitted to the undersigned **on or before 15 Jan 2019 by 17:00 hrs** in a sealed cover super-scribed clearly with "<u>OFFERS FOR SUPPLY OF RAW MATERIALS & PACKING</u> <u>MATERIALS FOR CATTLE FEED PLANT</u> **due on 15 Jan 2019**". Offer will be opened on 16 Jan 2019 at our above office at 15:00 hrs in presence of the suppliers who have offered rates or their representatives who may choose to be present.

Tender must be submitted not later than 17:00 hrs on 15 Jan 2019 in the manner specified in tender documents at the address given below:-

General Terms and Conditions

- 1. The rate by concerned suppliers shall be valid at least up to 30 days and they will have to supply the materials at the quoted rate as per ordered specification and as per the delivery schedule stipulated in the purchase order.
- 2. Rates shall be quoted on gross weight basis as per enclosed format. All statutory liability of taxes duties shall be of the suppliers and shall be borne by them within the rate offered.
- 3. The tenderers must indicate their GST, PAN and get registration nos in the offer, failing which the offer of the party will be summarily rejected. Applicable taxes (if any) must be specifically indicated in the offer even if the net offered rate is tax paid.
- 4. Depending on the volume of the quantity order may be distributed to more than one party without assigning any reason to any of the bidder. The item to be delivered by the vendor would be exclusively as per prescribed schedule. In case of non delivery the purchaser reserves right to procure the item from other sources as per vendors risk, cost, and volition. The purchaser reserves right to modify the schedule of delivery on arriving goods based on available stock with intimation to the vendor to comply and there thepurchaser is not entitled to give any clarification to the vendor.
- 5. Our payment terms shall be 80% within 20 days of receipt of materials and on physical verification and remaining 20% on receipt of test report within 45 days.
- 6. The prices should be quoted F.O.R. Destination inclusive of packing forwarding, taxes, insurance & transportation charges etc. Rate must be quoted in enclosed "Proforma for filing Tender".
- 7. **Consignee/Delivery address**: Medha Dairy Plant, Hotwar, (A unit of Jharkhand Milk Federation), Beside BirsaMunda Central Jail, Hotwar, Ranchi, Jharkhand 835217
- 8. On receiving orders from JMF, the supply of product at Jharkhand Milk Federation, Ranchi or any location specified by it shall be the responsibility of the supplier. The rejected material, if any, shall have to be lifted by the supplier at their own cost within a week time from the date of intimation either through telephone or email or letter from JMF. JMF shall not be responsible for any deterioration due to delayed lifting of the rejected material by the supplier. Delayed lifting by the supplier despite intimation may invite additional payments towards its storing charge at par with FCI norms or as decided by local authority. Materials can be rejected upon physical verification also.

- 9. The tenderers shall have to pay Earnest Money Deposit of Rs.10,000/- (Rupees Ten thousand only) in form of crossed Demand Draft in favour of "Jharkhand State Cooperative Milk Producers' Federation Ltd", payable at Ranchi while submitting the tender. Submission of earnest money by any mode other than specified above shall not be accepted and the related tender shall not be eligible for consideration. The suppliers once deposit EMD value as Rs 10,000/-, need not to deposit EMD in future participation, in case the same party retains such amount under custody of JMF. Those suppliers with all eligible criteria like GST registration, non defaulter and PAN details would be treated as registered participants in tender process.
- 10. Earnest money deposit of unsuccessful tenderers will be returned within 30 days from the date of opening of the tenders. The earnest money deposit of the successful tenderers shall be released on completion of successful supply of entire quantity allotted/ordered within the stipulated period against demand from the party.
- 11. No interest will be paid on the earnest money for the period during which it (the earnest money) lying deposit with the Jharkhand Milk Federation.
- 12. From every consignment the Quality Control Dept. of JMF may draw sample and shall forward the samples for checking the specification as mentioned for individual raw materials. The analysis would be done at JMF CFP laboratory or NDDB's laboratory (CALF). The test result of laboratories would be binding to obey for both the parties.
- 13. The materials to be delivered strictly as per prescribed specification. In case of deviation the JMF reserves right either to accept the goods after imposing **additional rebate** beyond acceptable guide lines in accordance to the consent of technical people of JMF or issue directive to lift the rejected goods as per partiescost, risk and volition within 15 days of intimation either through mail, or even telephonic messages too. Beyond above limit the rejected goods would be disposed of as per discretion of the purchaser and no correspondence on same would be entertained.
- 14. Materials to be suitably packed to prevent damages or any pilferages during transit. The weight of the material so received within the premises of JMF or as arranged by JMF would be binding to the supplier and in such cases supplier is authorized to engage its authorized representative during conducting the process of weighment at Hotwar dairy premises.
- 15. The payment to the party would be processed as per prescribed schedule as stated above through RTGS/NEFT.
- 16. JMF reserves the right to accept or reject any or all the offers without assigning any reason thereof. Managing Director, JMF shall be Arbitrator in case of any disputes and his decision will be final and binding on both the parties. For all legal matters & dispute Ranchi court shall be our Jurisdiction. Any money found recoverable shall be recovered under the public Demand Recovery Act without prejudice to any other mode of recovery.
