The sealed tender in complete in all respect along with Tender Document shall be received up to 02:30 P.M, dated 30.01.2020 which shall be opened on the same day at 03:30 P.M, in the presence of the interested bidders.

A. TENDER INVITATION /SUBMISSION DETAIL

- I. The interested Party/ bidder should submit its Company's profile in the format enclosed as **Annexure-I.**
- II. **Sealed Tenders** are invited from registered and resourceful scrap dealers to lift scrap materials on "as is where is basis" for the period from 01.02.2020 to 31.12.2020. The period may be extended as per discretion of the Management.
- III. The Tender/ Bid document shall be sealed and submitted at the below address on or before 02.30 P.M. on dt 30 JAN 2020.

- IV. The sealed Tender/ Bid should be submitted by filling the rate on the respective items in the space provided in the format (**Annexure-II**) without any cutting or re-writing.
- V. The interested parties/ bidders are required to deposit **EMD of Rs. 25,000/-** (INR Twenty Five Thousand only) along with the Tender in the form of Demand Draft (**DD**) drawn in favor of 'Jharkhand State Cooperative Milk Producers' Federation Limited' payable at Ranchi. The tender /bid shall not be accepted without EMD.
- VI. The EMD of successful bidder will be converted into Security Deposit (SD) and shall be retained till the completion of the Contract / Order validity period. No interest will be paid on this security deposit.
- VII. All the tenders will be acceptable only in 'Sealed Envelope' on or before the due date.
- VIII. The validity of the offered rate shall be 90 days from the date of opening of Bid/ Tender.
 - IX. The bidder has to sign & stamp each and every page of the tender document as a token of the acceptance of terms and conditions.
 - X. The interested parties/ scrap dealer needs to submit all valid registration /trade license copy dealing with sale/ purchase of scrap materials.
 - XI. Tender document handed over to the Federation duly signed and sealed in each page completed in all respect will be considered as the property of the Federation and the party does not right to get back the documents furnished therewith
- XII. The rate/ unit of respective scrap materials should be quoted /filled against each item in the space provided (in format Annexure-II) without any cutting or re-writing.

B. GENERAL TERMS AND CONDITIONS:

- 1. The tender shall be sealed and addressed to 'The Jharkhand State Cooperative Milk Producers' Federation Ltd.' superscribing "Tender of Scrap Sale" in the format provided in Tender document and must be submitted by 2.30 P.M. on 309.01.2020.
- 2. Scrap materials may be inspected by the tenderer from 10.00A.M. to 2.00P.M. on any working days before 29.01.2020 with the approval of the Head of the Unit concerned/ Store Dept./Section.
- 3. In case of Milk Crates, Cans, Fresh Polyfilms, the contractor/ party will arrange to cut the items at its won cost before lifting/ loading. The quantity declared for each unit is approximate where unit is Kg/No. This may increase or decrease at the time of final lifting as the materials are continuously generated during operation.
- 4. The rates must be kept valid up to 31.12.2020 from the date of execution of agreement. Any change in address of the tenderer shall forthwith be intimated to the Managing Director.
- 5. Lifting of scrap will be arranged by the party within 60 Days in consultation with the Head of the Unit after the award of the Work Order/ Contract. The Security deposit will be forfeited in case of non-lifting, avoiding to lift within schedule time.
- 6. Execution of lifting of scrap materials mentioned in Annexure-II will be **against 100% advance payment** within specific time frame in consultation with the Head of the respective Units concerned /Store Dept. as per the rate contract to be affected from the date of the agreement/ award of the Work Order.
- 7. Any scrap materials generated subsequently and within the tender period will be informed to the contractor and shall have to be lifted within 30 days of intimation/information.
- 8. The weighment taken at our Dairy/Unit is final & binding in nature and scrap materials once sold cannot be taken back.
- 9. Contract for scrap items can be given to more than one party depending upon the rates. This means the contract for the different items can also be given to different parties.
- 10. The contractor/party shall have no right to sublet all or any portion of the said job/ work on award of the contract/ Work Order after finalization of tender process.
- 11. In case failure of the selected party/contractor, if situation is compelled us to sell scrap to any party at lower rate the difference in selling amount will be recovered from the contractor or the amount will be adjusted from the amount of security deposit of the contractor. The selected tenderer/bidder shall have to lift the material on a regular basis as per verbal/written instruction of the authorized person, I/C of the Plant & Store Medha Dairy Plant, Hotwar, Ranchi. The communication of Plant I/C & Store I/C is final and binding to the contractor in this regard.

- 12. During the execution if any damage occur to the property of unit party will be liable to good or to bear the cost to make the same good.
- 13. If the party performance not found satisfactory at any time, the order will be terminated by giving seven days' notice period and will be diverted to some other party/parties and the party whose order is diverted shall have no right to claim.
- 14. A declaration must have to be submitted by the tenderer that he is well equipped with men, machine and funds to execute lifting as and when required.
- 15. The Management reserves the right to forfeit the **EMD** in case the successful bidder fails to execute the Agreement or avoid receipts of any communication or who violates any terms and conditions of the Agreement
- 16. The decision of the Managing Director of this Federation in each and every respect shall be final and binding upon the contractor and he is the sole arbitrator for any dispute regarding the scrap contract. The Management reserves the right to split the orders or reject any or all tender papers without assigning any reason thereof.
- 17. JMF reserves the right to accept or reject any or all the offers without assigning any reason thereof. Managing Director, JMF shall be Arbitrator in case of any disputes and his decision will be final and binding on both the parties. For all legal matters & disputes, Ranchi court shall be our Jurisdiction.
