Post pre-bid meeting held at The Jharkhand State Cooperative Milk Producers' Federation Ltd., Dhurwa, Ranchi on 28 June 2019 and the clarifications to queries received through mails regarding "Supply and Implementation of an open source based Enterprise Resource Planning (ERP) Software including configuration and customization with 3 years Maintenance Support", clarification/amendments/additions to the various tender clauses shall be as given below. All other terms & conditions written in the tender documents shall remain unaltered.

1	To clarify ownership and uses rights of developed ERP software & the Source Code will be the Intellectual Property Rights of JMF ?	Final source code should be provided to JMF, the final production build/copy will be generated from this source code. Both JMF and bidder are allowed to use the base source code.
2	How are updates of the ERP software covered under Warranty & under AMC	YES, as and when an update is released or there is a statutory requirement to update the system, the system shall be updated by the bidder without cost during implementation and warranty period. However it will be chargeable during AMC as per the amount quoted by the bidder.
3	Is there any strictness of database usability	No, but it should be free from Licence requirement. JMF will rate the proposed database provided by all the vendors on different parameter like security, performance, business scenario etc.
4	Can we change the modules under the mentioned phases of implementation.	Modules may be developed in phase wise manner which may be mutually decided after selection of the implementation partner.
5	What is on the fly custom report generation?	we need to have a query builder like engine, where in parameters can be set to generate process wise output in excel dump.
6	What is the scope of AMC	AMC covers all the minor development, New reports, bug fixing, up gradations and resolution of the issues within the signed SLA.
7	Clarification on different UoM mentioned in document	Bidder needs to quote for single UOM for each of the items under component B of financial bid (commercial bid)
8	Please share the details for which application need to be integrated with proposed ERP.	Proposed ERP is required to be integrated with NDDB's Developed AMCS only. AMCS is build on PHP and MySQL supporting REST API.
9	Milk Procurement schemes: Will it be handled under ERP or AMCS	If scheme is related to financials parameter only, then it needs to be handled in ERP.
10	Team Structure under technical evaluation criteria: Is it required to be onsite all the time during implementation.	Not all the time but, should be available during the crucial phases/activities and on request by JMF
11	Availability of the annexures in word format	Shall be provided on JMF official website.
12	Is consortium allowed for bidding	No
13	Proposal should be provided in Hard Copy or Soft copy ?	Please submit the soft copy in a hard media & printed copy along with the technical bid envelope duly sealed.
